Whereas, the Administrative Department vide letter No. L&E/Emp/35/2014 dated 09.11.2017 has forwarded the selection list of (08) candidates on the basis of recommendation made by the Services Selection Board vide letter No. SSB/Secy/Sel/2017/10464-70 dated 09.10.2017.

Whereas, out of (08) selected candidates only (02) namely S/Shri. Farooq Ahmad Wani S/o Sh. Mohammad Abdullah Wani R/o Lasjan & Sh. Mukesh Kumar S/o Sh. Mansa Ram R/o Durang Billawar, Kathua joined the Department and remaining (06) did not turn up.

Whereas, formal appointment Orders vide No. 346-ED of 2017 dated 29.11.2017 and No. 361-ED of 2017 dated 19.12.2017 was issued in favour of S/Shri. Farooq Ahmad Wani S/o Sh. Mohammad Abdullah Wani R/o Lasjan & Sh. Mukesh Kumar S/o Sh. Mansa Ram R/o Durang Billawar, Kathua.

Whereas, both the candidates joined the Department within the stipulated time period and were posted in District Employment & Counselling Centres of Pulwama & Kathua respectively.

Whereas, Shri Mukesh Kumar, Junior Scale Stenographer DE&CC, Kathua has tendered his resignation dated 10.02.2018 addressed to Deputy Director, District Employment & Counselling, Centre, Kathua requesting therein for acceptance of his origination w.e.f 18.01.2018 from the date he has remained absent. The said resignation was forwarded by Joint Director Employment, Jammu vide No. JDEJ/2017-18/1354 dated 05.03.2018.

Now, therefore, in view of above, the resignation of Sh. Mukesh Kumar, Junior Stenographer, DE&CC, Kathua is hereby accepted w.e.f 18.01.2018 on his own request and his lien in the Jammu & Kashmir Employment Department (Non-Gazetted) service shall and shall always be deemed to have been terminated.
