- b. That if the candidates have taken loan for Self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, they shall relinquish the proprietorship of Unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. They shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of proprietorship and stakes, if any, in such a self-

- employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointee(s) shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/ Date of Birth/ HGV/PSV Driving License and Relevant category Certificate is received from the concerned Authorities/ Agency.
- d. The appointee(s) shall be on probation for a period of two years.
- e. The appointment of the candidates shall be governed by the "NEW Pension Scheme" as notified vide SRO-400 of 2009 dated: 24.12.2009.
- f. The inter-se-seniority of the appointee(s) in the J&K Employment (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
